

# Northern California Agility League (NCAL) Registration Form

## THIS IS AN ALL NADAC SESSION - ALL MATCHES WILL BE NADAC

### August - September, 2018 / Session 48

The Northern California Agility League (NCAL) is a group of dog agility enthusiasts who have agreed to participate in team competition during a six-week session of one match per week, each match consisting of a standard/regular and a games course, on the dates and times specified below. NCAL offers participants the opportunity to have fun participating in the sport of dog agility on a variety of courses designed after the various styles of all U.S. sanctioned agility registries.

Weekly matches will be held at Agility Acres Recreation Facility (AARF!) located at 3598 Phillips Ave, Santa Rosa CA 95407 (please call 707-584-3478 or email [agilityacres123@gmail.com](mailto:agilityacres123@gmail.com) for directions). On match day, the site will be open NOT earlier than 5:00pm for set-up. Each match will begin with a briefing and walk-through at 5:30pm. The first dog will be on the line at 6:00pm and the match should be completed within approximately 90 minutes. ### Entries, Fees, Opening Postmark Date and Closing Date

To be eligible, participants (dogs and handlers) must be trial-ready. See Section 1.2 of NCAL Rules (rules can be downloaded from <http://agilityacres.net>) for all eligibility requirements. The safety of the dogs is of primary concern. ***As participants of the NCAL, handlers/owners acknowledge that they are familiar with the NCAL rules and that their dogs are familiar with and able to perform all agility obstacles safely.***

Participation in the six-week session is offered at a fee of \$90 per dog. Completed registration form must be accompanied by payment and mailed to: Maureen Lyons, 3598 Phillips Ave, Santa Rosa CA 95407. Please make checks payable to: Maureen Lyons.

Opening postmark for receipt of registration forms is August 9, 2018. Last date for receipt of registration forms is through 6pm on August 12, 2018, or until the maximum number of entries (32 dogs) is received.

This calendar is subject to change in the event of inclement weather or other unforeseen problems. In the event of inclement weather, contact your Team Leader (see NCAL Rules) or call 707-584-3478 to confirm. Make-up matches will be scheduled as best as possible.

Entry fees will not be refunded in the event that a dog is absent, dismissed, excused, or barred from participation by action of the NCAL League Coordinators: Jeff and Maureen Lyons.

A withdrawal from the NCAL after the closing date due to an injury and/or illness to the dog or for bitches that come into season after the closing date may be eligible for a refund of up to 75% of the total entry fees paid for remaining matches, less any administrative fees.

No entry fees will be refunded if any match cannot be held or completed by reason of riots, civil disturbances, fire, an act of God, public emergency, act of a public enemy, or any other cause beyond the control of the NCAL. In the event of a cancellation due to inclement weather, every effort will be made to reschedule the missed match; if this is not possible, refunds of unused fees will be made.

## RELEASE & INDEMNITY

In consideration for being permitted by Jeffrey and Maureen Lyons and to participate in dog training and related events at 3598 Phillips Ave, Santa Rosa California (the "Premises"), I hereby waive, release and discharge any and all claims for damages for personal injury, death, or property damage, including injuries to my dog(s) which I may incur, or which hereafter accrue to me, against Jeffrey and Maureen Lyons and Agility Acres Recreation Facility (hereinafter collectively the "Organizers") as a result of my participation in dog training or any activity(ies) while on the Premises. I am aware that dog training including dog agility training can be an inherently dangerous activity.

This release is intended to discharge the Organizers from and against any and all liability arising out of the negligence or carelessness on the part of the persons named against any and all liability arising out of or connected in any way with my participation in dog training and related activity(ies) on the Premises, even though that liability may arise out of the negligence or carelessness on the part of the persons mentioned above. I further understand that accidents and injuries can arise out of the activity(ies); knowing the risks, nevertheless, I hereby agree to assume those risks and to release and hold harmless all of the persons mentioned above who (through negligence or carelessness) might otherwise be liable to me, for damages.

I also state my dog(s) is/are not aggressive towards people or other dogs & that I understand I alone am responsible for the behavior of my dog(s), that any dog, which is out of control, creates an unnecessary disturbance or engages in unsafe or disruptive behavior, may at the discretion of the League Coordinators, be expelled from the event grounds with NO REFUNDS.

It is further understood and agreed that this waiver, release and assumption of risk is to be binding on me and my child's heirs and assigns. In addition, I agree to indemnify and hold harmless the Organizers from and against all claims, damages, losses and expenses including attorney fees arising out of my or my participation in dog training and related activity(ies) at the Premises.

By signing my name below, I affirm that I have carefully read the release and indemnity agreement and fully understand its contents. I am aware that this is a release of liability and agreement to indemnify the Organizers and I sign it of my own free will.
